- 1) After Welcoming & full participation is obtained, then Bircan elected as a chairperson
- 2) The Agenda was adopted.
- 3) For the record: The MINUTES of the March 27, 2017 Special Board Meeting was approved by the end of the "Special Board" Meeting, and already provided a signed copy to the pro-bono firm.
- 4) FINANCAL STATUS REPORT ON THE RECEIVED DONATIONS
 - As of May 1, 2017: Balance of the Organization's bank account is: \$319.00
 - As of May 4, 2017 (Bircan deposited/donated) \$100.00): \$419.00
 - 2016 IRS 990N e-card is filed on April 24, 2017 (see attachment)
 - CHAR500 2016 to the NYS Attorney of General will be filed the week of May 8th, 2017.
 - 5) **Required** need funds (Dan and BradStreet to completing the "uncompleted" credit report of the Organization;; due to restricted fund, we have not completed it.
 - 6) Status update re# 1023 Certificate of Incorporation "amending-broadening" the Mission-Purposes and updating-strengthening the By-Laws" of the organization. Bircan is emphasized that the Organization has been in a transition process since June 2015 that this Meeting is a regular and information based one.

Ref# April 21, 2017 dated Updated, "amending and broadening" the Mission-Purposes" and e-submitted full package was sent out to the Board of Directors prior to the Board Meeting on May 5, 2017.

- 6a) Based on the March 27, 2017 Board Meeting, hard copy of the MINUTES was signed off
- (by Hande) and delivered by Bircan to the Pro-bono Law Firm along with a \$30.00 filing fee.
- 6b) The pro-bono Law Firm re-submitted it on April 21, 2017, and shared it the all resubmitted package with the BoDs as in "**Confidential**".
- 6c) At this stage, we've been waiting for its APPROVAL Letter, which has not arrived yet.
- 7) Bircan nominates Ms. ASLIHAN CAKMAK as the Deputy Executive Director. A letter of Agreement in between two parties and the organization will be drafted based upon Approved Amended and Broaden PURPOSES of the Organization along with "updated-strengthen" By-Laws to be in effect follow by, once these both documents are officially and publicly in force. - a) A Letter to the UN was sent on March 6/7, 2017 in support of the SDG#16 and #17 in reference to the April 16, 2017, Turkish Referendum and Turkey's State of Emergency Status since July 2016. Bircan has launched and campaigned @OhalsizReferendum (#Turkey #Referendum #NotUnderStateOfEmergency) social media page on Feb. 16, 2017 towards repealing #StateOfEmergency in Turkey in support of the democracy, freedom, human rights and within the core of the UN SDG#16.

 - A report on the letter was published in Voice of America by Can Kamiloglu in the U.S., then multiple Turkish Media both in print, TV and online news media picked it up but without touching the core reason of the letter instead manipulating and defining it as if it was a complaint, which was not the nature and purpose of the letter, which created a cross fire and political anti-campaign through various social media platforms to Bircan and the Organization. The ones she was able to locate, she has worked tediously, and responded to each of them even the intention was very bad, insult, threat, throwing mud, bullying etc... She is still working and trying to deal any form of related attack through social media.




From April 1 2016 to March 31, 2017 Monthly on a monthly and based HITS and VISITS




